#### 1) New Business

- a. Approval of last meeting minutes

#### 2) Principals Report bulletin

- a. Kelly has communicated that CTK operating expenses sits at \$231,000 - \$51,576 resulting in approx. \$180,000 to be carried over. \$17,000 to be allocated to educational psychology assessments and programming. Enrollment is currently at 1162 projected to be 1170 with indigenous, inclusion and english as a second language to receive extra funding.
- b. New Modulares - Looking into adding bathrooms but Facilities want the bathrooms to be located on the east side of the building whereas bathrooms are needed on the west side, but in order to get west side bathrooms there will need to be some

major underground piping corrections. Additionally, Kelly is looking into AC's for the Modulars.

- c. Elizabeth, our VP is leaving CTK and going to St Bernadette as Principal. Kristy McCoy from St Gabrielle's replacing Elizabeth. Some teachers are going on maternity leave and some are returning.
- d. With the high number of inclusive kids currently in CTK, Kelly is exploring options from Joan Carr school on how they manage their inclusion program and is wanting to incorporate it at CTK. This will involve EA's, SLP's and Teachers to structure a plan for breakout rooms for literacy and numeracy. This vision will cost \$200,000 to start and to run will cost \$1,000,000 so the teachers are preparing a presentation to Terry Peterson, inclusive consultant, to ask for the funding support on April 11th. CTK is anticipating a reply on April 17th to see if it is approved.
- e. CTK applied for the PC grant again for next year, which will help support in-class snacks. Crystallina Shoppers Drug Mart has donated toiletry bags.
- f. June 24th is the scheduled Fun Day. The teachers are identifying what they will need and seeing if grocery stores will donate.
