Activity Summary

The School Council and Fundraising Association collaborated on three fundraisers:

- Fall: Little Caesars Pizza Kits,
- Christmas: FundScrip, Root Seller (poinsettias) and,
- Spring: Stawnichy's Sausage House and Root Seller (baskets and veggies).

We offered bi-weekly hot lunches, from September through June.

We were able to provide the teachers with an appreciation breakfast in June.

We used some of these funds to support community initiatives including:

- \$400 towards the Junior High Toy drive in December
- \$540 to The Stollery Children's Hospital Foundation

We invited Ward 72 Trustee, Sandra Palazzo, to present at our May meeting. She shared information with parents on ECSD's plans for the new Crystallina Nera School.

We received \$77,127 from our August 2023 casino share and almost \$40,000 to update educational equipment in the classrooms.
